This Show is to be held under the terms of a DEFRA General Licence to arrange a fair, market, show, exhibition or other gathering involving the collecting together of captive birds in England and all conditions must be complied with.

- b. **I understand the requirement for the Biosecurity Declaration form and I will complete the form and hand it in on the morning of the show.**
- c. **The birds do not originate from a premises or areas which are under restrictions within a Protection, Surveillance or other notifiable avian disease controlled zone.**
- d. **Ensure all baskets, crates are clean. No soiled or visibly contaminated baskets, with bird droppings or other material of bird origin, other than faeces produced during transportation of the birds to the gathering will be allowed into the venue.**
- e. **All Racing Pigeons entered have been vaccinated against the Paramyxovirus (PMV).**
- f. **I have read and understand the Show information and Conditions of Entry for the show, which are on page 2 of the schedule**
- g. **I agree to abide by NPA rules and the DEFRA General Licence requirements**
- h. **I am registered with the APHA and my CPH number has been entered on the entry form.**
